It was learned that further discussions would be held to decide the modalities and schedules of the future roundtable discussions.

The consultations were aimed at making the PASDEP as comprehensive and country-owned as possible, since the strategy document is expected to serve as the main framework for the country's development efforts, particularly in meeting the Millennium Development Goals (MDGs), in the next five years. The current approach contrasts with experiences in other African countries, where PRSPs were often not linked to the Millennium Development Goals (MDGs), as well as to other national strategies or programs.

PANE members had already deliberated on the draft Plan and submitted their written recommendations to MOFED. The roundtable meeting gave PANE members another opportunity to hold face-to-face discussions with government representatives on a number of issues relating to the sectoral programs of the draft PASDEP document and suggest improvements. PANE and MOFED had in the past collaborated in regional awareness campaigns on the SDPRP, MDGs, as well as in the Annual Progress Reviews of the SDPRP. MoFED and PANE also agreed to work on the upcoming regional and Wereda consultations on the PASDEP and MDGs.

The Poverty Action Network of Ethiopia (PANE) is a new network of civil society organisations working to reduce poverty in Ethiopia by influencing the PASDEP and other policy-making processes. PANE hopes to do this through research, policy analysis, advocacy and information sharing. PANE has regional chapters throughout Ethiopia and its membership represents a broad range of civil society organisations.

The following four organizations were elected as new Board Members. They are expected to be represented by permanently assigned staff:

- 1. Forum for Social Studies (FSS)
- 2. Agri-Service Ethiopia
- 3. Rift Valley Women and Children Development Association
- 4. Africa Initiative for Democratic World Order (AIDWO)

The working document sets forth the following objectives of the Civil Society internal dialogue:

To contribute to the clarification of the contentious issues amongst the three perspectives as regards voluntarily organized entities;

- To highlight commonalities among various types of voluntarily organized entities;
- To make issues of civil society a centerpiece of the democratization and development process; and
- To enable members of the sector to reach consensus among themselves on the designation of CSOs in the Ethiopian context.

It was proposed to organize a public forum at which experts would present papers and invited panelists would reflect on the presentations to enrich the discussions. The CSOs internal dialogue is provisionally scheduled to take place in mid-April 2006.

Public Meeting on Natural Gum and Incense

The Forum for Environment (FfE), in collaboration with Non-Timber Products Research & Development Project (NTFP), Ethiopian Coffee Forest Forum (ECFF) and Ethiopian Foresters Association (EFA) organized the first public meeting under the theme "Non-timber forest products: A win-win for poverty reduction and environmental protection". The meeting was held at Semien Hotel, Addis Ababa on 17 March 2006. It was attended by participants drawn from NGOs, CSOs, CBOs, private and government institutions that are involved in the Natural Gum and Incense economic sector. FSS was represented by Dr. Daniel Kassahun, the Environment Researcher.

Two papers on the botanical and socioeconomic aspects of gum and incense resources, authored by Dr. Mulugeta Lemeneh, Teshome Soromessa and Teshale W/ Amanuel, were presented and discussed at the meeting. While the annual potential production of gum and incense in Ethiopia is 300,000 tones per annum, the actual production is only 2000 tones, of which 50% is exported. The production process is reported to generate employment opportunity for 20,000-30,000 persons. During the discussions following the presentations, the current resettlement program taking place in the western lowlands of Ethiopia was pointed out as the major threat to the sustainability of gum and incense production. In addition, factors such as cross-border illegal trading, rapid forest degradation, poor infrastructure in the resource area, poor quality control system, and issues related to the ownership/tenure and absence of forest policy in the country were discussed during the meeting.

ESSSWA Holds 5th Annual Conference

The Ethiopian Society of Sociologists, Social Workers and Anthropologists (ESSSWA) held its 5th Annual Conference at the Addis Ababa Hilton Hotel on March 3 & 4, 2006. The theme of the conference was "HIV/AIDS Orphan and Vulnerable Children in the Eyes of Social Scientists and Development Practitioners". Six papers on various topics under the conference theme were presented and discussed during the two-day meeting.

Attending the conference were representatives of government ministries, UN agencies, bilateral organizations, and NGOs, including FSS.

The conference underlined the importance of the participation of all concerned in curbing the multifaceted problems of 4.6 orphans in the country. Speaking at the conference, Dr Bulti Gutema, Head of the Children and Family Affairs Department of the Ministry of Labour and Social Affairs, said although there are laws and policies that provide for the protection of orphans and vulnerable children, many children who are in dire need of assistance are not reached for a range of problems.

The number of vulnerable orphans has been increasing due to poverty, drought, HIV/AIDS and other social crisis, noted the UNICEF Youth and HIV/AIDS Department Head, Richard Mabala.

The Society has endorsed a three-year Strategic Plan after thorough discussions by its members. ESSSWA also accorded a special Award to Shimelis Adugna and Hirut Imru in recognition of their long years of dedicated service in the fields of Education and national development.

The ESSSWA was founded in June 1996 and officially registered in April 1997.
